Wildlands Restoration Volunteers seeks a <u>bilingual</u> Community Engagement Coordinator who is passionate about WRV's mission to heal the land and build community. This position will support WRV in engaging a diverse community of environmental stewards; this position will also support implementation of WRV's Equity and Inclusion Initiative by engaging the Hispanic/Latinx community in Longmont and across the Denver Metro area.

The Community Engagement Coordinator will support a year-round team of experienced staff and will be aided by a large corps of dedicated and inspiring volunteer leaders. Experience with environmental education and ecological restoration is a plus, but on-the-job learning in restoration skills and techniques is also possible. Leadership and technical training opportunities are provided, and staff may attend additional projects that are of interest to them in order to gain additional knowledge and experience.

\*Please note: WRV is continuing to allow staff to work from home, although office space will also be provided to all employees.

### **Required Skills:**

- Fluency in Spanish
- Culturally fluent with strong understanding of the needs of Hispanic/Latinx community members
- Understanding of and commitment to diversity, equity, and inclusion best practices
- Experience working and building relationships with diverse communities
- Project management skills
- Computer proficiency, including Microsoft Office
- Willingness to work evenings/weekends as needed this position will require participation in programming outside of typical working hours
- Able to balance multiple projects and deadlines
- Willingness to communicate and follow COVID-19 and other safety precautions

- Experience with environmental or outdoor education
- Experience working with people in nature
- Experience with volunteer engagement or group leadership
- Ability to safely use trucks on uneven terrain.

## Community Engagement Coordinator Job Description

The Community Engagement Coordinator will help WRV reach its goal of involving the local community in meaningful outdoor stewardship and environmental education. This position will support implementation of WRV's Inclusiveness Plan, with a focus on providing programming that is accessible to and inclusive of the Hispanic/Latinx community.

Below is a summary of specific responsibilities (percentages are approximate and change seasonally depending on the needs of the organization).

### Bilingual Outreach and Engagement (50-75%)

WRV engages thousands of volunteers each year in over 200 restoration, trails, and stewardship projects each year engaging thousands of volunteers. In recent years, we have expanded our bilingual programming to offer projects, trainings, and social activities in Spanish. As the Community Engagement Coordinator, you will take a lead role in growing existing relationships and building new partnerships with the Hispanic/Latinx community. This may include:

- Connecting with partners and community members to identify needs and build relationships
- Develop and implement outdoor stewardship events and activities
- Other activities to ensure that WRV outreach materials are available in Spanish and are available via appropriate outlets (i.e. social media, newsletters, texts, etc.)

This position will involve participating in and running outdoor stewardship events for community members. Most these events will be half-day, weekend activities along the Colorado Front Range. On the job training will be provided. A company vehicle or mileage reimbursement is provided, and food is provided at most events.

### Program Support (25-50%)

This role will also serve as support for other project and non-project activities, dependent on relevant experience. Specific duties will be discussed prior to making an offer so that candidates have full knowledge of the position. This may include:

- Maintaining contact information for volunteers and partners in the WRV database
- Managing photos and videos from events for use as marketing materials
- Creating print and/or social media outreach materials
- Attending in-person outreach events
- Carrying out assigned "bundled tasks" that support the smooth running of WRV's entire slate of season projects
- Responding to volunteer inquiries by phone and email
- General administrative and/or facilities support

WRV also runs a paid internship for low-income youth which meets weekly on most Saturdays during the school year (September through April, not including holiday weeks). Preference may be given to candidates who are interested in managing the internship program and have relevant experience working with youth, although others are encouraged to apply. If you are interested in this aspect of the position, please indicate your interest in your application.

**COMPENSATION:** WRV hourly compensation will be \$18.00 - \$21.00 per hour. This is a non-exempt position. Employee will earn overtime pay when they work over 40 hours in a week, or 12 hours in a day. Additional benefits include discounted pro-deals and professional development opportunities. WRV offers employees a competitive benefit package including group health insurance, paid time off, paid holiday time off, and Simple IRA enrollment with up to a 3% match.

**COVID-19:** WRV's COVID policy requires full vaccination against COVID-19 on your first day of employment. Request for reasonable medical or religious accommodations will be considered.
