In the year of a founder's transition, many nonprofits anticipate a financial loss. WRV was no different. And, thanks to the stock market bouncing back after year's end, what looks like a loss on paper has also turned around for our investments as of the date of this report. Your Influence

In addition to the stories featured in this report,

your 2018 gift supported volunteers to:

- plant >21,580 native plants, shrubs, and trees, which
 rebuild soil, improve fish and wildlife habitat, reverse the establishment
 of noxious weeds, prevent erosion, and absorb carbon.
- re-route, maintain or repair 6 miles of trail
 across a variety of landscapes, from Colorado's highest peak to trails
 near Frisco, Golden, Fort Collins & Boulder. Notably, you helped WRV
 on a five-year project to re-open the beloved Young Gulch Trail near
 Fort Collins, which was closed due to fire in 2011 and flooding in 2013.
- restore 3I acres of forest health.
 Decades of unnatural fire suppression in Colorado have degraded habitat for wildlife from birds to butterflies, and a warming climate has led to hotter, more intense fires that scorch the soil. Through selective forest thinning and removal of invasive tree species, you reduced the risk of wildfire in the wildland-urban interface, and helped native species return.
- spend I,506 hours collecting native seeds
 to be grown-out and multiplied for use restoring denuded habitat in the
 future. Locally-collected seed is uniquely adapted to conditions in our
 area, and far likelier to survive than commercially available seed.
- remove noxious weeds from 332 acres
 so that native species can return. Your help was used in efforts
 focused on ridding Colorado of A-listed weeds, which have been legally
 mandated for eradication due to the damage they cause.
- engage over 800 diverse youth in science-based restoration service learning, and so much more!
